- Why is Cunningham Telephone and Cable asking for all this information?  
Cunningham's is required by law from the Federal Communications Commission (FCC) to protect its customer information from fraudulent activity. One of the most important parts of protecting our customers is verifying who they are when a customer calls to setup, change or request information on their account. The information we are gathering helps us fulfill the FCC requirements.
- What is CPNI?  
CPNI is Customer Proprietary Network Information and consists of information that Cunningham's has about our customers such as numbers you call and particular services you have with us that we bill for. This is what we are protecting on your behalf with the FCC's CPNI regulations. This regulation protects our customers from fraudulent activities.
- What happens if I don't fill out the information required by Cunningham's?  
Cunningham's are accountable by law to help protect our customers' information and deter fraudulent activity including identity theft. We may have to refuse service to potential customers if the information is not filled out correctly. You may opt out of supplying your social security number.
